1. ESTIMATES

The attached development costs are based upon Hyperweb's current understanding of the scope of work and project specifications provided by Client. Hyperweb reserves the right to submit a new budget to accommodate any subsequent changes to its understanding of scope of work and/or project specifications.

Unless so specified, these estimates exclude any charges for third party intellectual property rights, and the costs of all travel, accommodation, couriers, per-diems, taxes, gratuities, and other expenses, which will be itemized separately upon completion of the project.

All estimates are quoted exclusive of taxes. Taxes will be charged at the prevailing rates at time of invoice.

2. CHANGES

Client will be advised of, and will be asked to approve in writing, any increased costs resulting from changes to specifications and/or the scope of work.

Please note that estimates have been calculated based on Hyperweb's ability to source, staff and deliver to the agreed upon Critical Path. If Client fails to meet its deadline, Hyperweb reserves the right to charge for any additional time and material costs that are incurred as a result.

3. PAYMENT SCHEDULE

A deposit of 50% of project total + HST is due on contract signing (project start), and the final 50% of project total + additional costs** + HST is due when project is reconciled. The final bill is payable within 30 days of receipt of invoice.

- ** The final payment may include in addition any change orders and additional costs authorized over and above the estimate, plus expenses.

Overdue invoices, including the deposit, will be subject to a 1% per month service charge.

4. CANCELLATION

If Client cancels the agreement at any time, it agrees to pay a cancellation charge equal to the total of all costs incurred to the time Hyperweb receives written notice of cancellation, including Hyperweb's normal charges for time spent by its employees and costs incurred because of the cancellation, including cancellation charges payable to third parties.
